Association is in receipt of grievance from Member Transporters as they have brought-out that Office of Assistant Commissioner, Commercial Tax, Noida (U.P.) has issued a range of notices under which it is brought to their notice that your good office has downloaded 'TDF-I' from Commercial Tax Department Website/Portal, U.P. State and noticed that TDF of product transported from other States to outside Uttar Pradesh Territory in their Vehicles are not disposed for which Member Transporters are advised to be present at your office for representing the case.

Association Members are astounded to note the contents of the notices issued to them from the Office of Assistant Commissioner. Because extensive period has passed away, presently they are not having any past record with them of material transported by their vehicles that has been delivered at the factory/site of consignee.

As mentioned in your notice/s that your good offices have downloaded TDF-I from Commercial Tax Department Website/Portal, U.P. State, we request your goodself to please provide a copy of TDF-I of respective notices to the Association Members or please keep the 'link' of the website/portal of Commercial Tax Department alive so that transporters can search and reply to the notices.

We on behalf of association members, request your goodself to look into the matter and make it convenient to give a line of action so that same can be communicated to them & oblige.
