## Sub: Pending issue of Free Hold Land of Gandhidham Township

Dear Sir,

Our chamber is actively representing the subject issue with Gujarat Government at various levels for last eight months which briefly highlighted as under:

- A delegation of The Gandhidham Chamber met twice Chief Minister & Revenue Minister of Gujarat and brief them about necessity of takeover of Gandhidham Township Land on Revenue Records of Gujarat Government to complete conversion process from lease hold to free hold and to bring the same to its logical conclusion. This was flowed by detail written submission on the subject matter. Thereafter in subsequent period, The Gandhidham Chamber also briefed Gujarat Government officers of various levels in person and with written submission. From time to time, local MP and MLAs were also kept in loop to shape-up land transferring procedure and to initiate further representation at various platforms. A joint meeting of Revenue Secretary of Gujarat Government also had with Officers of Deendayal Port Trust and Collector of Kachchh to chart out road map to resolve the matter. As we understand, you were also kind enough to have a discussion with Gujarat Government at Gandhinagar to expedite the whole transfer process and also express the desire to transfer commercial land to Gujarat Government.
- After above referred discussion with State Government Officials, we have gathered the impression that to execute line of action on Gazetted Notification, the state government requires certain explanation and compliances from Deendayal Port Trust which are still awaited.
