The family sources have revealed that the deceased had telephonic threatens regularly and having afraid of, he had lodged the police complaint. By the time period even the deceased was granted a police protection also.

They feel themselves uncomfortable to carry on business activity and routine living life. The entire society of various social organisations in the township has felt strong resentment against the brutal killing. At the same time society is optimistic that police will accelerate the action and nab the culprits within no time.
